BACKGROUND INFORMATION/FISCAL IMPACT:

This is companion legislation to the Bill to approve the collective bargaining agreement between Prince George's County, Maryland and Council 67, American Federation of State, County and Municipal Employees (AFSCME), AFL-CIO, and its affiliated Local 241 (School Crossing Guards) for Fiscal Years 2017 and 2018. This Resolution also reflects modifications to the agreement. A fiscal impact statement will be provided by the Office of Management and Budget.

The proposed salary plan amendments were submitted to the County Council by the County Executive on April 20, 2017. Pursuant to Section 903 of the Charter, if the Council fails to take final action on the proposed salary plan before June 19, 2017, the salary plan shall stand approved.

NOTE: CR-26-2017 is retroactively effective to July 1, 2016.
