WHEREAS, Se	ection 27-645 of the Zoning Ordinance for Prince George's County,
Maryland, requires t	the Prince George's Planning Board of The Maryland-National Capital Park
and Planning Comm	nission to submit its proposals for public facilities in the Plan to the District
Council and to the C	County Executive prior to adoption by the Planning Board; and

WHEREAS, the Zoning Ordinance also provides a review period for the County Executive and the District Council to review, provide written comments, and identify any inconsistencies between the public facilities proposed in the plan and any existing or proposed State or County facilities including roads, highways, or other public facilities; and

WHEREAS, Section 27-645 provides that the adopted plan may not include a highway or transportation line unless the District Council, after consultation with the County Executive, approves (by resolution) the inclusion of the highway or transportation line for planning purposes; and

WHEREAS, the Planning Board referred the public facilities element of the Preliminary Subregion 5 Master Plan and Proposed Sectional Map Amendment for review, comments, and the identification of any inconsistencies between the public facilities proposed in the plan and any existing or proposed State or County facilities on March 9, 2009, attached hereto as Attachment A; and

WHEREAS, upon review the District Council has concluded that, in general, the new and modified public facilities transportation proposals contained in the Preliminary Subregion 5 Master Plan are consistent with the county's Capital Improvement Program ("CIP") and the State's Consolidated Transportation Program ("CTP").

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, sitting as the District Council for that part of the Maryland-Washington Regional District in Prince George's County, Maryland, that the transportation system and public facilities proposals in the public facilities element of the Preliminary Subregion 5 Master Plan and Proposed Sectional Map Amendment, as transmitted on March 9, 2009, by the Prince George's Planning Board of The Maryland-National Capital Park and Planning Commission, are hereby approved for inclusion in the preliminary master plan.

BE IT FURTHER RESOLVED that the District Council intends to further review the plan and its public facilities element following the joint public hearing and receipt of the adopted plan from the Planning Board and may, at that time, revise the plan and its transportation system if changes appear justifiable and consistent with long-range goals and objectives.

BE IT FURTHER RESOLVED that a copy of this Resolution be forwarded to the Chairman of the Prince George's Planning Board.
