BILL

AN ACT concerning

Plastic Food Containers

FOR the purpose of prohibiting the sale of food by drive-in and fast food restaurants in plastic containers which are not biodegradable, returnable or separated at the point of sale for recycling.

BY adding:

SUBTITLE 21. REFUSE.

Section 21-149.1,

The Prince George's County Code (1987 Edition, 1988 Supplement, as

amended by CB-58-1989).

BY repealing and reenacting with amendments:

SUBTITLE 21. REFUSE.

Section 21-152,

The Prince George's County Code (1987 Edition, 1988 Supplement, as amended by CB-58-1989).

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that new Section 21-149.1 be and the same is hereby added to the Prince George's County Code to read as follows:

restaurant, as defined in Subtitle 27 of this Code, to sell or dispense food or beverages that is placed, wrapped or packaged at any time at or before the time or point of sale in or on plastic containers or in or on plastic foam containers unless such containers are degradable, returnable or are separated at the point of sale for recycling. A drive-in restaurant or fast-food restaurant which provides on-site recycling receptacles and recycles at least fifty percent (50%) of plastic of plastic foam food or beverage containers used by the restaurant shall be deemed to have complied with the provision of this section requiring separation of such containers at the point of sale for recycling.

SECTION 2. BE IT FURTHER ENACTED that Section 21-152 of the Prince George's County Code be and the same is hereby repealed and

reenacted with the following amendments:

DIVISION 4. SOLID WASTE RECYCLING.

Subdivision 4. Administrative Provisions.

Sec. 21-152. Penalties.

- (a) Any person who violates Section 21-147, [or] Section 21-149 or Section 21-149.1 of this Code is deemed to have committed a civil violation and shall pay to the County a civil monetary fine as prescribed in this Section.
- (b) Each separate day of violation that remains uncorrected is a distinct civil violation subject to an additional citation and fine.
- (c) The civil monetary fine for each civil violation of Section 21-147, [or] Section 21-149 or Section 21-149.1 shall be One Hundred Dollars (\$100.00) except as provided in Subsection (d) of this Section.
- (d) For a repeated civil violation the following fines shall apply:

2nd violation - \$500.00

3rd violation - \$750.00

Each violation in excess of three - \$1,000.00

(e) In addition to and not in lieu of any other penalties prescribed in this Section, any person who violates Section 21-147, [or] Section 21-149 or Section 21-149.1 of this Code is guilty of a misdemeanor and, upon conviction thereof, shall be subject to a fine not to exceed One Thousand Dollars (\$1,000.00), or imprisonment not
