RESOLUTION

1 A RESOLUTION concerning

2 The Redevelopment Authority of Prince George's County Fiscal Year 2016
3 Operating Budget and Capital Improvement Program

4 For the purpose of approving the Capital Improvement Program of the Redevelopment Authority
5 of Prince George's County for Fiscal Years 2016-2021; prepared pursuant to the authority
6 contained in Subtitle 15B of the Prince George's County Code; and providing comments on the
7 proposed Operating Budget of the Redevelopment Authority for Fiscal Year 2016.

8 WHEREAS, Section 15B-124 of the Prince George's County Code provides that the
9 Redevelopment Authority of Prince George's County may propose one or more projects for
10 inclusion in the Redevelopment Authority's Capital Improvement Program; and that the County
11 Executive shall transmit to the County Council for its approval by resolution or ordinance any
12 such project approved by the County Executive; and

13 WHEREAS, the County Executive has proposed for approval three Capital Projects for the
14 Redevelopment Authority's Capital Improvement Program which consists of project numbers
15 UM900995 County Revitalization, UM900053 Glenarden Apartments Redevelopment and
16 UM900985 Suitland Manor, copies of which are attached hereto and incorporated herein by
17 reference as though they were set forth fully herein, identified as Attachment 1; and

18 WHEREAS, Section 15B-123 of the Prince George's County Code provides that if the
19 proposed operating budget of the Redevelopment Authority includes any item to be funded from
20 payments to be received from the County that the anticipated receipts shall be identified for each
21 item and a copy of the proposed budget shall be transmitted by the Redevelopment Authority to
22 the County Executive and the County Council for their review and comment; and

1 WHEREAS, the Redevelopment Authority has forwarded its proposed operating budget to
2 the County Executive and the County Council for review and comment as shown in the
3 Appendix to the FY 2016 proposed budget.

4 SECTION 1. NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince
5 George's County, Maryland, that subject to and in accordance with the authority of the Charter of
6 Prince George's County and pursuant to Subtitle 15B of the Prince George's County Code, the
7 Capital Improvement Program for Fiscal Years 2016-2021 of the Redevelopment Authority of
8 Prince George's County, as submitted by the County Executive to the County Council, is hereby
9 amended, authorized, approved and adopted as reflected in Attachment 1.

10 SECTION 2. BE IT FURTHER RESOLVED that the County Council has reviewed the
11 proposed Fiscal Year 2016 Operating Budget of the Redevelopment Authority of Prince
12 George's County and concurs with an Operating Budget of \$770,500 for the Redevelopment
13 Authority, as reflected in Attachment 2.
