Department of Housin	g and Community Development (the "Department") of the State of		
Maryland or through o	other departments or agencies of the State of Maryland.		
WHEREAS, Art	icle 83B, Section 4-801 through Section 4-811 of the Maryland Annotated		
Code established the C	Community Legacy Program, to preserve existing communities as desirable		
places to live and cond	duct business and provide financial assistance to sponsors for the		
development of comm	nunity legacy plans or community legacy projects; and		
WHEREAS, Art	icle 83B, Section 4-806 (B) (1) of the Maryland Annotated Code provides		
that the Community L	egacy Board may not approve an application for participation in the		
Community Legacy Program unless the application is approved by the local government; and			
WHEREAS, the	Departmental requirements necessitate approval of the designation of a		
Community Legacy A	rea, the Plan and the Plan Financing by Prince George's County; and		
WHEREAS, Prince George's County recognizes that there is a significant need for			
reinvestment and revitalization of the communities in Prince George's County; and			
WHEREAS, the	Redevelopment Authority of Prince George's County proposes to (i)		
lesignate the area of Suitland in Prince George's County, as outlined on the map attached hereto			

as Attachment 1 (the "Area") as a Community Legacy Area and to (ii) develop Community

Legacy Projects (the "Projects") in the "Community Legacy Area", the purpose of which will be to contribute to the reinvestment and revitalization of the Area; and

WHEREAS, Suitland has a current revitalization plan (Suitland Revitalization Action Plan, 1997) and a strategy (Neighborhood Revitalization Strategy, 2000) and has proposed projects within the area that are consistent with said plan and strategy; and

WHEREAS, the Department, either through the Community Legacy Program or through other Programs of the Department, or in cooperation with other state departments or agencies, may provide some or all of the financing for the Plan (the "Plan Financing") in order to assist in making it financially feasible; and

WHEREAS, the County Executive expresses approval of the application and receipt of financing for a Suitland Community Legacy Area, the Suitland Community Legacy Plan and the Plan Financing in Prince George's County under the Department's Community Legacy Program;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland that the recitals to this Resolution are hereby incorporated by reference herein and deemed a substantive part of this Resolution.

BE IT FURTHER RESOLVED that the County Council of Prince George's County, Maryland hereby approves the application, attached hereto as Attachment 2, to the Community Legacy Program submitted on behalf of the community in Suitland, Maryland.

BE IT FURTHER RESOLVED that the County Council of Prince George's County, Maryland hereby endorses the designation of a Suitland Community Legacy Area and the Plan in the community of Suitland; and hereby approves the Plan Financing in the form of a grant or loan in the approximate amount of \$900,000.00.

SECTION 2. BE IT FURTHER RESOLVED that copies of this Resolution be sent to the Secretary of Housing and Community Development of the State of Maryland for consideration by the Community Legacy Board.
