The briefing convened at 12:09 p.m. J. Kenneth Battle, Jr., Director, Transportation, Infrastructure, Energy and Environment Committee (TIEE) provided an overview of the Climate Action Commission. Council Member Dernoga provided comments as a member of the commission. Mr. Battle introduced Andrea Crooms, Director, Department of Environment (DOE), who introduced the participants and facilitated a Powerpoint presentation titled, "CLIMATE PRIORITIES A Vision for RESILIENCE in Post-Pandemic Prince George's County." The presentation highlighted the following: THE TIME IS NOW, AND THE NEED IS URGENT; Climate Impacts Are Already Here; If we don't stop climate change now, your predicted future, based on your current age; Stage of Life by Year 2050 Representing 68 % of Prince George's County's Current Population; We Must Act Now While WE Still Have a CHOICE; CLIMATE ACTION PLAN; CLIMATE AND THE COUNTY Where we are, and where we need to go; Our County is Experiencing More Frequent and More Intense Events; Inaction is no longer an option; Insurance companies, major banking institutions, creditors, relators, and more are beginning to heavily weigh climate risks as a factor for approving investments; Financial Loss and Claims; In a climate altered future, for a thriving Prince George's County, we must change our relationship with land and nature; Transformational Leadership is Needed; So how is land use a climate change contributor?; Can we achieve a 50% GHG reduction?; RECOMMENDATIONS; A Call for Transformational Leadership and Change; OPERATIONAL- COUNTY ACTIONS Actions needed to bring the other recommendations to life; MITIGATION; ADAPTATION/RESILIENCE; Why our Code of Ordinance must now be significantly revised and cyclically updated here forward?; ADAPTATION/RESILIENCE; OPPORTUNITIES & VISION The County we want to be; Climate Change CHOICES: What will our lives be like for 68% of Prince George's County Population by Year 2050?; Generational Opportunity to Thrive and Prosper; Prince George's County is Particularly Vulnerable; OUR EDUCATIONAL INSTITUTIONS: Critical for a Prosperous and Equitable Carbon Neutral Future; CALL TO ACTION The
