It is my pleasure to submit to you and the County Council the appointments of Ms. Shelia F. Bryant, Mr. Kelvin D. Davall, Mr. Lafayette D. Melton, Ms. Marsha A. Ridley, and Mr. Daniel C. Vergamini to the Prince George's County Police Accountability Board (PAB). I am appointing Kelvin Davall as Chair. The establishment of the PAB is a direct result of HB 670, one of several bills under the Police Accountability Act of 2021, passed in 2021 by the Maryland legislature.

Ms. Shelia F. Bryant, a resident of Upper Marlboro, is an attorney and a frequent volunteer with the Prince George's County Community Legal Services providing free legal services to residents. She has twenty years of experience as an Inspector General with the United States Marine Corps. Ms. Bryant possesses an undergraduate degree from Jackson State University; a Juris Doctor from Thomas Jefferson School of Law; and a Master's in Public Administration from Harvard Kennedy School.

Mr. Kelvin D. Davall, a resident of District Heights, is the current Chair of the Citizens Complaint Oversight Panel. He has experience in review of complaints by citizens and creation of recommendations for reform. Mr. Davall attended the Citizens Police Academy. Professionally, he is a Computer Engineer with Hewlett Packard, LLC.

Mr. Lafayette Melton, a resident of Upper Marlboro, has over a decade of experience as Human Resources and Diversity, Equity and Inclusion professional with talent acquisition, retention, and communication expertise. He has worked in the non-profit and federal government sectors. Mr. Melton is a graduate of Goucher College and Bowie State University.

Ms. Marsha A. Ridley, a resident of Mitchellville, is a current member of the Citizen Complaint Oversight Panel. Professionally, she is an accomplished manager with thirty years of recognized leadership, strategic planning and policy development and is currently employed by the Teamsters Union.

Mr. Daniel C. Vergamini, a resident of Capitol Heights, is a current member of the Citizens Complaint Oversight Panel. He is currently an Assistant Director working performance audits at the U.S. Agency for International Development's Office of Inspector General.
