RESOLUTION

1 A RESOLUTION concerning

2 The Creation of a Food Truck Hub in Downtown Upper Marlboro

3 For the purpose of authorizing the creation of a Food Truck Hub in Downtown Upper
4 Marlboro.

5 WHEREAS, Section 5-189.01 of the Prince George’s County Code generally requires that a
6 Food Truck Hub shall only be located on the open area or parking lot or public rights-of-way of
7 the following: parks and recreational facilities under the operation and control of the Maryland-
8 National Capital Park and Planning Commission, or areas within a one-quarter mile radius of the
9 station entrance of any Metro and MARC stations; and

11 WHEREAS, the Food Truck Hub located at 14525 Church Street, Upper Marlboro,
12 Maryland 20772 (See attached Exhibit) is neither located in the parks and recreational facilities
13 under the operation and control of the Maryland-National Capital Park and Planning
14 Commission, nor areas within a one-quarter mile radius of the station entrance of any Metro and
15 MARC stations; and

16 WHEREAS, The Town of Upper Marlboro desires to create a Food Truck Hub at its Town-
17 owned parking lot in this location; and

18 WHEREAS, Section 5-189.01 authorizes that Food Truck Hubs not located at parks and
19 recreational facilities under the operation and control of the Maryland-National Capital Park and
20 Planning Commission or areas within a one-quarter mile radius of the station entrance of any
21 Metro and MARC stations may be granted special authorization by resolution of the County
22 Council; and

23 WHEREAS, the Downtown Upper Marlboro Food Truck Hub must still satisfy the

1 requirements for the Food Truck Hub License as enumerated in Section 5-189.03 of the County
2 Code and remain subject to approval by the Department of Permitting, Inspections, and
3 Enforcement pursuant to Section 5-189.01 of the County Code.

4 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
5 County, Maryland, that the County Council does hereby grant special authorization to the
6 Downtown Upper Marlboro Truck Hub to become a Food Truck Hub.

7 BE IT FURTHER RESOLVED that such authorization by the County Council is subject to
8 the Town of Upper Marlboro satisfying the requirements for the Food Truck Hub License as
9 enumerated in Section 5-189.03 of the County Code and subject to approval by the Department
10 of Permitting, Inspections, and Enforcement pursuant to Section 5-189.01 of the County Code.
