COMMITTEE OF THE WHOLE REPORT

Committee Vote: Favorable, 7-0-1, (In favor: Councilmembers Russell, Bailey, Estepp, Gourdine, Hendershot, Scott and Wilson. Abstained: Maloney).

This bill will provide a \$3 million grant to Dimensions Health Corporation (DHC) to support the continuation of essential health services to the citizens of Prince George's County. This bill is an emergency act since it affects the public health, safety and welfare. Also, this appropriation will increase the FY2001 General Fund revenues and expenditures by \$3 million.

Date: 6/19/01

The chairman of the Board of Directors for Dimensions Healthcare expressed support for this legislation. Dimensions serves a vital role in the County by providing care for approximately 200,000 patients annually. A breakdown of these statistics will reflect that the typical patient is African-American (59%), female (58%), and from Prince George's County (85%). The

uninsured accounted for almost 40,000 patients (20%), while those covered by Medical Assistance accounted for 35,000 (18%).

Dimensions has engaged a nationally recognized management consulting firm, Cap Gemini Ernst and Young, to review all system operations and recommend opportunities for improvement.

DHC is very grateful to County Executive Curry for his recognition of the important role that they play in providing health care to the residents of Prince George's County.

There will be a negative fiscal impact on the County as a result of enacting CB-43-2001.
