BACKGROUND INFORMATION/FISCAL IMPACT:

This bill would create a Local Diverse Supplier Prime Contractor Program, under which the Purchasing Agent would reserve a percentage of the aggregate value of procurements awarded each year solely for bids, proposals, and awards for prime bidders, prime proposers, and prime contractors that are either locally-owned and operated businesses or County-based minority business enterprises. The bill would provide for certain exemptions and public notice of reserved solicitations for procurements, and would require annual reporting to the County Council.
