Dear Chair Ivey:

It is my pleasure to submit to you and the County Council the appointment of Mr. Rhet A. Roe, and the reappointments of Ms. Joy R. Anderson, Mr. Orlando A. Bonilla, Ms. Tisa J.D. Clark, and Mr. Lino V. Cressotti to the Wage Determination Board for Prince George's County. The Board's primary responsibility is to establish schedules of prevailing hourly rates of wages for workers and apprentices employed on public works projects.

Ms. Joy R. Anderson, a resident of Brandywine, is President/Owner of JRA & Associates, a minority, woman-owned business in Prince George's County. Ms. Anderson manages all aspects of the general and mechanical contracting company with an annual volume of \$10,000,000. She is the President of the Alexander Square Condominium Association Board of Directors, a member of the Associated Builders and Contractors as well as the Prince George's County Construction Works Program Business Advisory Council. Ms. Anderson will serve as a Management Representative on the Board.

Mr. Orlando A. Bonilla, a resident of Laurel, is currently employed as the International Representative for Laborers' Union of North America (LIUNA!) Mid-Atlantic Regional Office where he provides management and organizing support for LIUNA!'s district council offices and local union offices. In this role, he assists with contract negotiations, contract enforcement and grievances investigations. Mr. Bonilla also works with union signatory employers to obtain wages and benefit data for submission, to maintain union prevailing wages on construction projects funded by the federal, state, and local governments. He will serve as a Labor Representative on the Board.

Ms. Tisa J.D. Clark, a resident of Upper Marlboro, is the President/Owner of J.D. Clark Professional Services, LLC, an environmentally conscience and energy conservation construction and maintenance firm. JD Clark, established in 2008, specializes in facilities maintenance, grounds management and renovations. She is a member of numerous business and professional organizations. Ms. Clark will serve as a Management Representative on the Board.

Mr. Lino V. Cressotti, a resident of Beltsville, currently works as a Liquor Board Inspector for Baltimore County. He previously served as Business Manager for Heat & Frost Insulators and Allied Workers Local #24 for fifteen (15) years and as Chief Administrator to the 450 members. Mr. Cressotti was responsible for preparing and submitting prevailing wage/Davis Bacon information in multiple jurisdictions

throughout Maryland, Virginia, and the District of Columbia. In addition to his position with the Union, he served in the construction industry for more than thirty-five (35) years. He will serve as a Labor Representative on the Board.

Mr. Rhett A. Roe, a resident of Bowie, is a life-long Prince Georgian with more than forty-five (45) years of experience in the electrical trade. He has trained electricians in code requirements and various aspects of the trade prior to retiring in 2021. Mr. Roe continues to serve as a member of the National Electrical Code. He has worked as a General Foreman for several jobsites including the Pentagon and multiple Prince George's County Public Schools. He will serve as the Public Representative on the Board.
