For the purpose of approving certain transfers of appropriations within the Administration Fund				
of the Approved FY 2026 Operating Budget of the Maryland-National Capital Park and Planning				
Commission.				
WHEREAS, the Annual Budget and Appropriation Ordinance for the Prince George's				
County portion of	the Maryland-National Capital Park and Planning Commission (M-NCPPC)			
for Fiscal Year 2026 was adopted on May 29, 2025, as CB-055-2025; and				
WHEREAS, within Appendix A of the Approved Fiscal Year 2026 Budget, a specific				
appropriation in the amount of \$70.125 million was approved for those administrative functions				
which are not shared with Montgomery County, including \$47.362 million for the Prince				
George's County Planning Department and \$9.355 million for project charges which reimburse				
the County for work done in support of the Commission; and				
WHEREAS, since the Annual Budget Ordinance was approved, the County and the				
Commission have identified additional opportunities to partner through the Office of the County				
Executive on economic development planning; and				
WHEREAS, in order to immediately take advantage of these opportunities, there is a need				
to decrease funding approved within the FY 2026 Budget for the Planning Department; and				
WHEREAS, Title 18 of the Land Use Article, Annotated Code of Maryland, authorizes the				
County Council to amend the adopted budget by resolution, provided that prior to amending the				
budget, the Counc	budget, the Council receives recommendations from the County Executive and holds a public			

hearing on the proposed amendment.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the following adjustments to the approved Fiscal Year 2026 M-NCPPC Operating Budget Administration Fund, as approved in CB-055-2025, are hereby made for the purposes set forth above:
