RE: Fiscal Year 2024 Final Operating Budget Transfers (Post-Close)

Dear Acting County Executive Jackson and County Council Chair Ivey:

This letter requests approval of the two final operating budget transfers from categories with unexpended appropriations authority remaining to categories that exceeded appropriation levels for FY 2024. Total revenue and expenditures remain at the Board of Education Approved Budget level of \$2,813,515,115.

These Financial Reviews were originally approved by the Board of Education on September 26, 2024 and October 24, 2024. Please note that this transmittal to the County Administration and County Council was held initially due to the change in board members and board elections. The transmittal was subsequently held at the request of County Council staff during the change in County Council and Council elections.

PGCPS Administration and the Board of Education regularly monitor the financial condition of the school system throughout the fiscal year and enact periodic adjustments to meet evolving needs of the District and ensure fiscal stability. The September 26, 2024 and October 24, 2024 Post-Close Financial Review included budget realignments and transfers between existing major state categories, as required, as well as ensuring alignment with Generally Accepted Accounting Principles in our Annual Comprehensive Financial Report as of June 30, 2024.
