Current Noise Ordinance

Residential

- Enforceable 24/7 Noise Level Dependent
- 50' Measurement From All Four Sides Of The House
- 65 dBA Day (7 a.m. to 9 p.m.)
- 56 dBA Night (9 p.m. to 7 a.m.)

Construction

- From 7 a.m. to 6 p.m.
- 75 dBA If The Department (DPIE) Has Not Approved A Noise-Suppression Plan For The Activity
- 85 dBA If The Department (DPIE) Has Approved A Noise-Suppression Plan For The Activity.
- Noise Levels Must Be Measured At The Location, At Least 50 Feet From The Source, On A Receiving Property Where The Noise Is Greatest.

o Commercial

- 67 dB Day (7 a.m. to 9 p.m.)
- 62 dB Night (9 p.m. to 7 a.m.)


Noise Ordinance Penalties

- Any Person, Who After Instructed To Cease The Noise Shall Be Subjected To Fine Not To Exceed \$500 For A First Offense
- \$1,000 For Each Subsequent Offense Or Imprisonment Not Exceeding 30 Days Or Both
- As An Alternative To Criminal Action, The Director, Police Chief, Enforcement Officer Or Police Officer May Issue A Civil Citation For Any Violation Not Exceeding \$500 For A First Offence, And \$1,000 For Each Subsequent Offense

How Are Noise Complaints Received & Resolved

- Citizen Complaint In Person
 - Officer Will Notify Public Safety Communications
 - Respond Immediately
 - Resolved On Scene
- Complaint Is Filed Through 911
 - Call For Service Will Be Generated And Dispatched
 - Response Time Can Vary Depending On Call Volume
 - Typically, Within 10-20 Minutes
 - Resolved On Scene

How Are Noise Complaints Received & Resolved (Cont.)

- Complaint is filed through 311 Or By Email To Division Commander
 - Response Time Can Vary And Take Up To A Few Days
 - These Tend To Be Long Term In Nature
 - On Going Loud Party Complaints & Pop-Up Events
 - Investigation Initiated By JAG (Joint Agency Group)
 - DPIE Included If Nuisance Property Is Established
 - Construction
 - DPIE
 - Division COPS Officers

Noise Ordinance Enforcement

- Up Until Recently, Noise Meters Were Not Available
 - This Made Enforcement Challenging
 - All Calls For Service Were Mediated At The Patrol Officer Level
- To Remedy This, Noise Meters Have Been Purchased
 - Purchased Through Departmental Budget
 - Each Noise Meter Costs \$126.00
 - 8 Were Ordered And Issued To All 8 Patrol Divisions
 - Total Cost \$1,051.08

Noise Ordinance Enforcement

- Up Until Recently, Noise Meters Were Not Available
 - Exception Division II And Special Operations Division
 - Loud Parties
 - FedEx During Events
 - This Made Enforcement Challenging
 - All Calls For Service Were Mediated At The Patrol Officer Level
- To Remedy This, Noise Meters Have Been Purchased
 - Purchased Through Departmental Budget
 - Each Noise Meter Costs \$126.00
 - 8 Were Ordered And Issued To All 8 Patrol Divisions
 - Total Cost \$1,051.08

- Create Awareness And Education Though Social Media & Departmental Components
 - Media Relations Division
 - COPS Officers
 - Community Meetings
- Involvement And Coordination With HOA's
