Dear Chair Hawkins:

As required by CB-73-2021/Sec. 26-114.02. "Authority to install and utilize residential district speed monitoring systems", which was adopted by the County Council on November 9, 2021, I am requesting that the County Council schedule and conduct a public hearing to garner public comment on the attached list. The list labeled as "First Phase Residential Speed Camera Locations" includes locations that staff in the Department of Public Works and Transportation (DPW&T) and the Prince George's County Police Department (PGCPD) have determined are initial locations that will make a significant impact on advancing safety and the principles of Vision Zero. Accidents and speed evaluations were used to identify these locations as candidates for first phase designation.

This list defined as "First Phase Residential Speed Camera Locations" comprises potential installation sites. However, this list is not exhaustive, and those locations cited have not been finally determined as automated speed enforcement locations. They are provided as examples of locations that could, if requested, potentially result in automated speed enforcement. Ultimately, each potential location will be evaluated individually utilizing safety centered, data-based criteria.

In addition, the legislation makes changes to the provisions set forth in CB-37-2009, pertaining to the establishment of a citizen advisory committee to meet periodically for the purpose of obtaining additional public comment. The composition now requires two (2) representatives from each Council District selected by the respective Councilmembers, two (2) representatives from each At-Large Council Member and three (3) representatives from the Office of the County Executive for a total of twenty-five (25) members. Consequently, I encourage the Council Members to identify and appoint their representatives as quickly as possible. Please send the names and associated contact information to the attention of Captain Jason Smith, Prince George's County Police Department, at jcsmith1@co.pg.md.us.

The authority given by the state and subsequent County legislation provides an important new tool to help us make our county roadways safer for all users. It is important that we expeditiously take the necessary steps to enable its usage. Therefore, I ask that the Council schedule a public hearing within the next 30 days to allow for the prompt

implementation of the residential automated speed enforcement program.
