BILL

1 AN ACT concerning

2 An Interproject Transfer of Appropriations in the Approved Fiscal Year 2010 Capital Budget
 3 For the purpose of transferring appropriations to the Fairwood Elementary School project and the
 4 Crossland High School Auditorium project.

5 WHEREAS, the Charter of Prince George's County, Maryland provides for the adoption of
 6 the County budget, which includes the capital budget and capital program; and

7 WHEREAS, pursuant to CB-19-2009, the County Budget, known as the Annual Budget
 8 and Appropriation Ordinance of Prince George's County for Fiscal Year 2010, which includes
 9 the Fiscal Years 2010-2015 Capital Improvement Program - Fiscal Year 2010 Capital Budget
 10 was adopted and amended; and

11 WHEREAS, the Approved Fiscal Year 2010-2015 Capital Improvement Program sets forth
 12 the plan of the County to receive and expend funds for capital projects during the fiscal year
 13 covered by the capital budget and the next succeeding five fiscal years thereafter and also the
 14 means of financing said projects; and

15 WHEREAS, pursuant to Section 814 of the Charter for Prince George's County, Maryland,
 16 the County Council may authorize, by legislative act, upon request of the County Executive,
 17 interproject transfers of appropriations between capital projects in the capital budget; and

18 WHEREAS, the County Executive deems it desirable to provide additional appropriations
 19 through an interproject transfer of appropriations to the Fairwood Elementary School
 20 (AA779773) and to the Crossland High School Auditorium (AA770893) as currently existing
 21 appropriations are inadequate; and

1 WHEREAS, pursuant to Section 814 of the Charter, the County Executive recommends that
2 appropriations can be transferred from the Laurel High Auditorium & Classroom Addition
3 (AA779825), as an excess of appropriations over estimated costs in the budget year exists; now,
4 therefore

5 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
6 Maryland, that the Fiscal Year 2010 Approved Capital Budget is hereby amended, as shown on
7 Schedule A, Schedule B and Schedule C, attached hereto and made a part hereof, to provide
8 additional appropriations through an interproject transfer of appropriations as follows:
