Dear Chair Ivey:

It is my pleasure to submit to you and the County Council the reappointment of Ms. Alicia A. Doney and Ms. Michelle L. Rice to the Redevelopment Authority Board of Prince George's County. The Redevelopment Authority Board acquires land and property within Prince George's County for residential, commercial or industrial development or redevelopment, and for the revitalization of the County's older communities.

Ms. Alicia A. Doney, a resident of Upper Marlboro, is a Managing Director working on Fannie Mae, Freddie Mac and Federal Housing Administration (FHA) financing opportunities. She has more than twenty (20) years of experience in multifamily lending and over thirty (30) years in commercial real estate. Ms. Doney is a member of African American Real Estate Professionals (AAREP), Housing Association of Nonprofit Developers (HAND), Women in Housing and Finance, and is the former co-President of Real Estate Network Empowering Women (RENEW). She received her Bachelor of Arts degree from California State University, Northridge and is currently Vice Chair of the Revenue Authority Board.

Ms. Michelle L. Rice, a resident of Upper Marlboro, is President of TV One and CLEO TV which are solely owned by TV One (formerly Radio One). She previously served as General Manager and had oversight of all business, operational and creative aspects for both networks. Before joining TV One in 2004, Ms. Rice worked at iNDemand, NBC Cable Network, and Black Entertainment Television (BET). She is actively involved on boards of various industry, local civic, community and charitable organizations and was inducted into the Class of 2022 Cable TV Pioneers, *the* most prestigious award honoring, and uplifting leaders in the cable TV industry. Ms. Rice received her undergraduate degree from Temple University and a graduate degree from the University of Southern California.

Pursuant to Section 15B-118 of the Prince George's County Code, I am appointing Ms. Alicia A. Doney and Ms. Michelle L. Rice to the Redevelopment Authority for Prince George's County.
