- County DOE staff shared and discussed a presentation outlining the Modac Lane beautification plan.
- Stating this plan is an extension of the tree planting project that began in 2024.
- This step will add various trees and shrubs to add to the appeal of the property, and to improve environmental health.
- Council inquired about whether this plan has the ability to go beyond Modac Lane Park adding shrubs and other beautification to the Community Garden, Veterans Park, etc.
- Landscape Architect/Project Manager provided details stating that this may in fact be possible depending on the what may be remaining upon completion of the Modac Park Project & will work with Town administrator on a plan to move forward.
- Mayor Lilly confirmed that additional Town enhancements can be included in the current resolution.
- Ideal start time of this project is September.

 - Ms. Feliz informed the council that a partnership may be required to move forward on opportunities that include County property.

EMERGENCY ORDINANCE NO. 02-25 | AN EMERGENCY ORDINANCE OF THE MAYOR AND COUNCIL OF THE TOWN OF FOREST HEIGHTS, MARYLAND AMENDING AND REVISING ARTICLE 15 (PARKING AND TRAFFIC) OF THE TOWN ORDINANCE CODE TO ADD SECTION 15.6.2 (STOP SIGN MONITORING SYSTEMS) AUTHORIZING THE USE OF STOP SIGN CAMERAS IN TOWN; AMENDING SECTION 15.13 (PENALTIES, REMEDIES; AND FEES) TO CHANGE OR ESTABLISH CERTAIN FINES OR FEES; AND GENERALLY RELATING TO AUTOMATED TRAFFIC ENFORCEMENT SYSTEMS.

- Rob Carr- provided background about areas currently using services, provided presentation on the type of violations seen in the county,
- provided information on dashcam item and what services they provide,
- discussed results that have been determined through evaluation of approximately 12 municipalities,
- discussed reasons that contribute to the violations being seen. Budgets, lack of community by in, cell phone use, etc.
- Discussed the issues that prevent services such as Obvio being used in communities, main issue being community by in.
- Video footage provides concrete evidence of violations with results are presented to the Mayor & Council quarterly.
- TOFH-2,784 violation within the TOFH in 12 intersections

Q&A ensued regarding

- Stop Signs reported as not visible
- evaluations done of the stop signs to determine if the stops are viable.
- · how certain markings in the road may cause confusion and may need to be re-evaluated.
- Importance of having the technology used near schools.
- Mayor Lilly mentioned camera implementation will help to assess current stop signs and if changes need to be made.

Mayor Lilly states this Ordinance allows changes to the Town code for execution. Attorney Best highlight specific language in the Ordinance that shows changes that will be made, states fines are not definitive, discretion allows lowering fines. Clarification on whether we are bound to amounts indicated for speeding however you will have the ability to modify in the future, A new Ordinance would be required to determine change of fees, Note added that results can help to determine if changes needed to be made, where does community education for residents (Obvio will be invited to speak with public before implementation) Town will host for residents to be provided information, Can community be educated in a timely fashion, Personal experience shared by CP about witnessing someone being hit by a car further stating the importance. Attorney Best adds Stop signs camera fine is \$40
