LEGISLATIVE HISTORY

FISCAL POLICY & GOVERNMENT OPERATIONS COMMITTEE DATE: 6/17/92

Committee Vote: Favorable as amended, 5-0 (In favor: Council Members MacKinnon, Bell, Castaldi, Del Giudice and Fletcher).

Some highlights of the agreement:

- (1) 7% COLA is retroactive to April 1, 1992.
- (2) Reduction and suspension of holiday premium pay rates until 6/93.
- (3) Suspension of extra day pay or compensatory time provision until 6/93.
- (4) Increased annual leave carryover from 115 days to 125 days.

- (5) Suspension until FY 94 of increase in employee health insurance contribution.
- (6) Officers may purchase additional pension credit after 20 years of service with available annual and sick leave.

Proposed amendments:

- (1) On page 2, line 10, insert the following new language:

"BE IT FURTHER RESOLVED that the provisions of this resolution shall supersede the provisions of CB-13-1992."
