**ZONING BILL**

1 AN ORDINANCE concerning

2 R-55 Zone

3 For the purpose of amending the development regulations in the Zoning Ordinance for the R-55  
4 (One-Family Detached Residential) Zone to provide a maximum number of bathrooms permitted  
5 for residential structures.

13 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
14 Maryland, sitting as the District Council for that part of the Maryland-Washington Regional  
15 District in Prince George's County, Maryland, that Section 27-419.02 of the Zoning Ordinance of  
16 Prince George's County, Maryland, being also Subtitle 27 of the Prince George's County Code,  
17 be and the same is hereby added:

**Sec. 27-419.02. Maximum Number of Bathrooms in the R-55 Zone.**

Residential structures in the R-55 (One-Family Detached Residential) Zone shall have no more than five (5) bathrooms for that structure or a combination of the primary residential and any accessory use on the property. At least one bathroom within any structure on the property must be accessible from a common interior area, such as a hallway.

SECTION 2. BE IT FURTHER ENACTED that this Ordinance shall take effect forty-five (45) calendar days after its adoption.
