### REPORT:

Committee Vote: Favorable, 11-0 (In favor: Council Members Turner, Hawkins, Anderson-Walker, Davis, Dernoga, Franklin, Glaros, Harrison, Ivey, Streeter and Taveras)

The Committee convened on October 8, 2020, and again on October 22, 2020 to consider the establishment of spending control limits for the Fiscal Year 2022 Operating and Capital Budgets of the Washington Suburban Sanitary Commission (WSSC). The Spending Affordability Working Group, consisting of staffs from the Montgomery and Prince George's County Councils and both County Executive's offices, met with WSSC staff on September 9th and September 23rd to specifically discuss the establishment of spending control limits that can be endorsed by both Counties. The goal of the Spending Affordability process is for the Prince George's and Montgomery County Councils to jointly set certain budgetary limits by November 1st of each year. These limits provide direction to WSSC for the formulation of the Commission's proposed budget. Both Councils reviewed the information compiled by the staff relating to spending control limits on: the percentage of water and sewer rate increase, new debt, debt service and operating expenditures.

Canjor Reed, Office of Audits and Investigations, provided a detailed overview of the Fiscal Year 2022 Spending Control Limits at the 10/8/20 COW meeting. Ms. Reed explained the various scenarios presented by WSSC and additional scenarios requested by the Working Group. WSSC's proposed based case scenario consisted of a 7.9% rate increase for FY2022. After requests from the Working Group, the Commission also presented forecasts at the 6.6% and 5.9% levels as well. After review of the three scenarios, staff recommended a spending control limit of 6.6%. The Committee voted to hold the issue until the 10/22 meeting.

The Committee of the Whole continued its review on 10/22, where Mr. Kenneth Battle, TIEE Committee Director, provided a recap of the 10/8 discussion and discussed the difference between the 6.6% and 5.9% spending limit scenarios. Mr. Battle indicated that the 5.9% scenario will require \$3.9 million in unspecified reductions to WSSC's Operating Budget, without any impact on any Prince George's County projects in the currently approved WSSC CIP. The Prince George's County Executive recommended support of a 6% spending limit. Mr. Battle reported that the Montgomery County Council T&E Committee recommended 5.9% at their 10/7/20 meeting.

After comments from WSSC General Manager Carla Reed and her leadership team, the Committee voted to recommend the following spending control limits for WSSC for FY2022 to the full Council:

Maximum Average Rate Increase: 5.9%  
New Water and Sewer Debt: \$427,880,000  
Water and Sewer Debt Service: \$309,733,000  
Total Water and Sewer Operating Expense: \$841,372,000

At the conclusion of the discussion, the Committee voted favorably on the above Spending Control Limits for FY 2022 by a vote of 11-0.
