BACKGROUND INFORMATION/FISCAL IMPACT:

This bill requires a landlord to pay to a tenant a relocation payment if the tenant's housing is condemned as unfit for human habitation under certain circumstances. Further, it requires a landlord

to provide a tenant with a right of first refusal to re-occupy rental housing under certain circumstances.
