**RESOLUTION**

1 A RESOLUTION concerning

2           The Washington Suburban Sanitary Commission Fiscal Years 2017-2022

3           Capital Improvement Program and Fiscal Year 2017 Capital Budget

4           for Prince George's County for Water and Sewerage

5 For the purpose of adopting with amendments the WSSC Fiscal Years 2017-2022 Capital  
6 Improvement Program and Fiscal Year 2017 Capital Budget for Water and Sewerage.

7       WHEREAS, Section 23-304 of the Public Utilities Article, Annotated Code of Maryland,  
8 requires the Washington Suburban Sanitary Commission (hereinafter "WSSC") to submit before  
9 October 1 of each year a Capital Improvement Program to the County Executive for Prince  
10 George's County; and

11       WHEREAS, Section 23-304 of the Public Utilities Article, Annotated Code of Maryland,  
12 requires the County Executive to transmit said Program together with comments,  
13 recommendations, and suggested amendments to the Prince George's County Council; and

14       WHEREAS, this Capital Improvement Program must contain, at a minimum, major  
15 projects as that term is defined in Section 23-301 of the Public Utilities Article, Annotated Code  
16 of Maryland, including water and sewerage projects; and

17       WHEREAS, this WSSC Capital Improvement Program is part of the Adopted County  
18 Comprehensive Ten Year Water and Sewerage Plan and contains projects to support water  
19 supply and sewerage system development as proposed in the Plan; and

20       WHEREAS, in accordance with Section 17-202 of the Public Utilities Article, Annotated  
21 Code of Maryland, the Washington Suburban Sanitary Commission did timely submit to the  
22 County Executives of Prince George's and Montgomery Counties the record of the public

1 hearing held by the Commission on the said Capital Improvement Program; and

2 WHEREAS, the WSSC has delivered its Capital Improvement Program to the County  
3 Executive; and

4 WHEREAS, the Prince George's County Executive has transmitted to the Prince George's  
5 County Council, the WSSC Capital Improvement Program, together with such comments and  
6 recommendations as were deemed appropriate; and

7 WHEREAS, Section 23-306 of the Public Utilities Article, Annotated Code of Maryland,  
8 further provides that after notice, the County Council shall approve, disapprove or modify the  
9 WSSC Capital Improvement Program provided that the WSSC is afforded an opportunity to  
10 comment on suggested modifications; and

11 WHEREAS, the Montgomery and Prince George's County Councils concurred with the  
12 recommended changes at the May 12, 2016 Bi-County Meeting; and

13 WHEREAS, all other requirements of Section 23-306 of the Public Utilities Article,  
14 Annotated Code of Maryland, that concern final action by the Council on the WSSC Capital  
15 Improvement Program for Water and Sewerage have been met.

16 BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the  
17 Capital Improvement Program Fiscal Years 2017-2022, and the FY 2017 Capital Budget as  
18 transmitted by the County Executive, are hereby adopted as amended by the attached  
19 Appendices, copies of which are attached hereto and incorporated herein by reference as though  
20 they were set forth fully herein, identified as Appendix A and Appendix B.
