PUBLIC SAFETY AND FISCAL MANAGEMENT COMMITTEE REPORT Date: 6/19/97

Committee Vote: Favorable, as amended, 3-0, (In favor: Council Members Wilson, Gourdine and Scott).

This bill will establish a Spending Affordability Committee by replacing the Board of Revenue Estimates, expand the composition from three to five members, broaden the scope of the committee and alter the reporting deadlines to provide input at a time that coincides with the County's budget development calendar.

Also, the County's full spending affordability capacity will be housed in this committee which is similar to committees that exist in neighboring jurisdictions.

This bill was amended as follows:

Page 1 delete lines 20 and 26 and insert: "1995 Edition, 1996 Supplement."

There should not be any negative fiscal impact of the County as a result of enacting CB-50-1997.
