Sec. 27-467.01. Motor freight facilities.

Any Motor Freight Trucking Operation, <u>as</u> defined [pursuant to] <u>in</u> Section 27-107.01, which [has] <u>had</u> a valid permit [issued prior to] <u>on</u> December 31, 1992, shall <u>continue to</u> be considered a permitted use[, provided the use has not changed to a different use since issuance of the permit]. This provision [shall apply only] <u>applies</u> to the property which was the subject of the original permit, <u>regardless of intervening uses</u>.

SECTION 2. BE IT FURTHER ENACTED that this Ordinance shall take effect forty-five (45) calendar days after its adoption.
