COMMITTEE REPORT**DATE:** 4/4/90

Committee Vote: Favorable, 3-0 (In favor: Council Members Pemberton, Bell and Wilson)

The Committee reviewed each project proposal and agreed with the County Executive's recommendation for all of the projects except #20 Takoma Park. The Committee recommended that \$22,000 be removed from Takoma Park's \$69,000 recommendation and applied to #17 North Brentwood. During the Committee's review of North Brentwood's proposal, the Town indicated that several of their previous years street construction projects were not being completed in a timely manner. Subsequently, the DPW&T indicated that an additional \$21,000+ was needed to complete the Town's request for the following street projects:

- o Wallace Road
- o Windom Road
- o Church Road

In reviewing project #25 Center for Community Development of Prince George's County request of \$16,805 to purchase a van for transporting seniors for appointments and activities, the Committee recommended the organization investigate a vehicle acquisition program administered by the DPW&T with State funds.

BACKGROUND INFORMATION/FISCAL IMPACT

(Includes reason for proposal, as well as any unique statutory requirements)

Approval is needed of Sixteenth Program Year (1990-1991) Community Development Block Grant Program and authorization of submission to U.S. Department of Housing and Urban Development to secure the annual entitlement amount of \$5,132,000. There is no impact on County general funds. This annual CDBG application is requested by HUD to be approved by the County Council and submitted to HUD at least 30 days prior to HUD approval of the County's annual grant contract.
