**BACKGROUND INFORMATION/FISCAL IMPACT:**

This bill adopts the M-NCPPC's operating and capital budgets for Prince George's County for Fiscal Year 2016, and establishes the tax rates as shown below. The total tax rate is proposed at 29.40 cents per \$100 of assessed value of real property and 73.50 cents per \$100 of assessed value of personal property.
