WHEREAS, the C	harter of Prince George's County, Maryland provides for the adoption of
the County budget, which	ch includes the capital budget and capital program; and
WHEREAS, pursu	ant to CB-32-2001, the County budget, known as the Annual Budget and
Appropriation Ordinanc	ee of Prince George's County for Fiscal Year 2001-2002, which includes
the Fiscal Year 2002-20	007 Capital Improvement Program - Fiscal Year 2002 Capital Budget was
adopted; and	
WHEREAS, the A	pproved Fiscal Year 2002-2007 Capital Improvement Program sets forth
the plan of the County t	o receive and expend funds for capital projects during the fiscal year
covered by the capital b	udget and the next succeeding five fiscal years thereafter and also the
means of financing said	projects; and
WHEREAS, pursu	ant to Section 818 of the Charter for Prince George's County, Maryland,
the County Council may	y authorize, by legislative act, upon request of the County Executive,
interproject transfers of	appropriations between capital projects in the Approved Capital Budget;

WHEREAS, the County Executive deems it desirable to provide additional appropriations for the Ritchie Road - Section II capital project (FD666411) and the County Buildings - Major Renovations capital project (SQ300033) as currently existing appropriations are inadequate for project completion; and

WHEREAS, the County Executive recommends that appropriations can be transferred from the Contingency Fund, as an excess of appropriations over estimated costs in the budget year exists; and

WHEREAS, the County Executive recommends the amendment of the Approved Fiscal Year 2002-2007 Capital Improvement Program with regard to the Ritchie Road - Section II capital project to reflect a change in expenditures and financing beyond the budget year; now, therefore

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that the Fiscal Year 2002 Approved Capital Budget is hereby amended, as shown on Schedule A, Schedule B and Schedule C, attached hereto and made a part hereof, to provide that appropriations are transferred as follows:
