**BILL**

1 AN ACT concerning

2 Long Term Parking on Public Highways, Roads, and Streets

3 For the purpose of reducing the time that a motor vehicle or trailer can be parked on a public  
4 highway, road, or street from seventy-two (72) hours to twenty-four (24) hours unless adjacent to  
5 the owner's home or business and amending the fine for a parking violation.

6 BY repealing and reenacting with amendments:

7 SUBTITLE 26. VEHICLES AND TRAFFIC.

8 Section 26-122,

9 The Prince George's County Code

11 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,  
12 Maryland, that Section 26-122 of the Prince George's County Code be and the same is hereby  
13 repealed and reenacted with the following amendments:

14 **SUBTITLE 26. VEHICLES AND TRAFFIC.**

15 **DIVISION 8. PARKING REGULATIONS.**

16 **Sec. 26-122. - Parking for longer than twenty four [seventy-two] hours prohibited.**

17 (a) [No person shall park or allow to stand any vehicle on any of the public streets or  
18 roadways in the County for a period in excess of seventy-two (72) hours.] The parking of motor  
19 vehicles and trailers upon the public highways, roads, and streets in the County for a period  
20 longer than twenty-four (24) hours is hereby prohibited; except when not otherwise prohibited  
21 adjacent to property lines of owner's residence or business.

1 (b) Any person issued a citation for a violation of this Section shall be subject to a fine of  
2 Two-Hundred and Fifty Dollars (\$250.00) [Fifty Dollars (\$50.00)] for each violation.

3 SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)  
4 calendar days after it becomes law.
