RESOLUTION

1 A RESOLUTION concerning

2 Reduction of the fee for the Mobile Unit Food Service Facility in the Table of Fees

3 For the purpose of reducing the fee for the Mobile Unit Food Service Facility found in the Table
4 of Fees.

5 WHEREAS, the Food Truck Hub Program was created to encourage economic
6 development, increase public access to healthy food options, minimize or eliminate food deserts
7 in underserved areas of the County, and promote innovative entrepreneurship and revitalization
8 in furtherance of the public safety, health and welfare of the citizens and residents of Prince
9 George's County; and

10 WHEREAS, the County Council of Prince George's County, Maryland, established the
11 Food Truck Hub Oversight Committee to provide continuing oversight and support of the Food
12 Truck Hub Program created by CB-16-2015 and CB-17-2015; and

13 WHEREAS, the Food Truck Hub Oversight Committee was established to assist with the
14 implementation of legislation and review and make recommendations to ensure the success of
15 Food Truck Hubs in the County; and

16 WHEREAS, the Food Truck Hub Oversight Committee believes the Food Truck Hub
17 Program is not yet reaching its potential to encourage economic development, increase public
18 access to healthy food options, minimize or eliminate food deserts in underserved areas of the
19 County, and promote innovative entrepreneurship and revitalization in furtherance of the public
20 safety, health and welfare of the citizens and residents of Prince George's County; and

21 WHEREAS, the Food Truck Hub Oversight Committee believes a permanent reduction of
22 the fee associated with a Mobile Unit License will assist the program in achieving the established

1 goals mentioned above; and

2 WHEREAS, this permanent reduction is considered an amendment to the Table of Fees
3 found in Section 2-253.63 of the County Code and therefore must be subject to legislative review
4 and approval by the County Council by resolution, after notice and public hearing, pursuant to
5 Section 2-253.63.

6 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
7 County, Maryland, that the fee entitled "Food Service Facility – Mobile Unit" for the Food
8 Service Facility-Mobile Unit License found in Attachment A, Table of Fees of Section 2-253.63
9 shall be reduced from Six Hundred Forty Dollars (\$640.00) to Three Hundred Dollars (\$300.00)
10 and associated technology charges shall be eliminated.

11 BE IT FURTHER RESOLVED that this amendment to the Table of Fees found in Section
12 2-253.63 of the County Code is approved only after notice and public hearing, pursuant to
13 Section 2-253.63.
