- South 3°44'13" West 1412.10 feet to a point the Right of Way Line of Thru Highway, as shown on Maryland State Roads Commission Plat 17233; thence, binding on said Right of Way Line of Thru Highway
- 2) South 35°41'29" West 15.06 feet to a point; thence
- 3) North 25°27'39" West 35.22 feet to a point; thence
- 4) South 72°39'01" West 31.19 feet to a point the 2nd or North 12°15' West 70 perch line of that conveyance from Samuel Bieber and Johanna Bieber, his wife, to the United States of America, by deed dated November 21, 1891 and recorded among the Land Records aforesaid in Liber JWB 20, folio 150, said point being in or near the centerline of the existing Bald Eagle Road (30' Prescriptive Right of Way); thence, binding on part of said line
- 5) North 16°05'15" West 1085.76 feet to a point at the beginning of the 3rd or North 10°30' East 26.4 perch line of said deed; thence, binding on part of said line
- 6) North 6°39'45" East 340.59 feet to a point at the southwestern most corner of the before said plat outline of Forest Heights; thence, continuing along the same course, binding on the western most outline of the before said plat of Forest Heights and the easternmost outline of the before said conveyance from Bieber to the United States of America (Liber JWB 20, folio 150)
