## RESOLUTION

## A RESOLUTION concerning

A Supplementary Appropriation of Grant Funds

FOR the purpose of providing \$191,134 to the Police Department for
the operation of a Financial Investigations Unit (FINVEST) and
providing for County in-kind funding.

WHEREAS, CB-55-1991, as amended, adopted and enacted the Annual Budget and Appropriation Ordinance of Prince George's County for Fiscal Year 1991-1992 which set forth the amount of grant funds to be appropriated; and

WHEREAS, under the provisions of Section 819 of the Charter of Prince George's County, Maryland, the Council, upon recommendation of the County Executive, may, by resolution, make additional or supplementary appropriations from Federal, State or private grants which were not included in the budget for the current fiscal year; and

WHEREAS, grant funding from the U.S. Department of Justice in the amount of \$191,134 is to be provided to the Police Department through the Bureau of Justice Assistance to create and operate a Financial Investigations Unit (FINVEST); and

WHEREAS, the Director of Finance has certified in writing that such funds are available for such appropriation; and

WHEREAS, the County Executive has duly recommended that this supplementary appropriation be made;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the Fiscal Year 1991-1992 Approved Current Expense Budget, Federal Programs Section, as amended, is revised by a supplementary appropriation as follows:
