Dear Chair Hawkins:

It is my pleasure to submit to you and the County Council the appointment of Mr. Todd M. Turner, Esq., as the Executive Director for the Prince George's County Office of Ethics and Accountability. The Office of Ethics and Accountability was established in 2012 to provide increased accountability and oversight in the operations of County government by identifying fraud, abuse, and illegal acts therein.

The Honorable Todd M. Turner, Esq., a resident of Bowie, is currently a member of the Prince George's County Council and Vice Chair of the Transportation, Infrastructure, Energy, and Environment (TIEE) Committee. He served as Chair of the County Council from 2018-2020. He previously chaired the Transportation, Housing and Environment, and Rules & General Assembly committees, and served as a Public Safety & Fiscal Management committee member. Chair Turner represents the County Council on the Washington Metropolitan Council of Government's Board of Directors; the Washington Suburban Transit Commission (WSTC); and is a member of the Maryland Association of Counties (MACO) Legislative Committee, and Large Counties Coalition. Prior to his election to the Council, Chair Turner served as a Legislative Officer for the County Council from 2007 through 2014. He is a former Bowie City Council Member, elected to represent the 3rd Council District from 2005 through 2009; elected to an At-Large Bowie City Council seat in 2011; and reelected to that seat in 2013.

Mr. Turner earned his undergraduate degree from Lafayette College and received his Juris Doctorate from the City University of New York School of Law. He has bar admissions in Maryland, District of Columbia and the New York Supreme Court, Appellate Division.

Pursuant to Sections 322 and 504 of the Prince George's County Charter and Section 2-300 of the Prince George's County Code, I am appointing Todd M. Turner, Esq. to serve as the Executive Director of the Office of Ethics and Accountability for Prince George's County.
