RESOLUTION

1 A RESOLUTION concerning

2 Salary Schedule P, Schedule of Pay Grades - Police Civilian Employees Association
3 For the purpose of amending the Salary Plan of the County to add three new grade levels not
4 previously utilized in Schedule P for the Police Civilian Employees Association (PCEA) in
5 accordance with recent amendments to the Classification Plan.

6 WHEREAS, pursuant to Section 903 of the Prince George's County Charter and Section
7 16-125(a) of the Prince George's County Code, amendments to the County's Salary Plan are to be
8 submitted to the County Council in resolution form; and

9 WHEREAS, pursuant to Section 903 of the Prince George's County Charter and Section
10 16-125(a) of Subtitle 16 of the Prince George's County Code, the County Executive
11 recommended and submitted amendments to the Classification Plan for Prince George's County
12 with respect to a certain class of work requiring a salary range not currently covered by Salary
13 Schedule P, Police Civilian Employees Association, which amendment was adopted by
14 CB-66-2000; and

15 WHEREAS, the County Executive has submitted an amendment relating to Salary
16 Schedule P to said classification plan amendments;

17 SECTION 1. NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince
18 George's County, Maryland, that the Salary Schedule amendments submitted and recommended
19 by the County Executive on June 26, 2000, which are attached hereto and made a part hereof,
20 adding three new grade levels, P-19, P-20 and P-21 to Salary Schedule P, Schedule of Pay
21 Grades, Police Civilian Employees Association, be and the same are hereby approved.

1 SECTION 2. BE IT FURTHER RESOLVED that all other provisions of Salary Schedule
2 P, Police Civilian Employees Association, shall remain unchanged.
