RESOLUTION

1 A RESOLUTION concerning

2 Joint Land Use Study Implementation Committee

3 For the purpose of amending the composition of the 2009 Joint Base Andrews Naval Air Facility
4 Joint Land Use Study Implementation Committee.

5 WHEREAS, the Prince George's County Council adopted CR-30-2010, establishing
6 the 2009 Joint Base Andrews Naval Air Facility Washington Joint Land Use Study (JLUS)
7 Implementation Committee to facilitate implementation of the JLUS recommendations; and

8 WHEREAS, the County Council desires to include further representation on the Task
9 Force regarding the assistance that can be provided from the general public in Prince George's
10 County to ensure compatible development adjacent to Joint Base Andrews and thereby assisting
11 the local government in protecting the public health, safety, and welfare; and

12 WHEREAS, Section 506 of the Charter provides that the Council may appoint, for
13 designated periods, one or more temporary advisory boards of citizens of the County who shall
14 assist in the consideration of County policies and programs.

15 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
16 County, Maryland, that the composition of the JLUS Implementation Committee is hereby
17 amended to include additional representation of interest.

18 BE IT FURTHER RESOLVED that the JLUS Implementation Committee shall be
19 composed of 17 members as follows:

- 20 1) Two representatives of the Prince George's County Council;
- 21 2) A representative of the Office of the County Executive;
- 22 3) A representative of the Prince George's County Planning Board;

- 1 4) A representative of the Prince George’s County Economic Development Corporation;
- 2 5) A representative of the United States Department of Defense;
- 3 6) A representative from the leadership of Joint Base Andrews;
- 4 7) A representative of the Maryland Department of Business & Economic
- 5 Development, Office of Military and Federal Affairs;
- 6 8) A representative of a business, trade or commercial organization;
- 7 9) A representative of the business industry;
- 8 10) A representative of the development industry;
- 9 11) A representative from a civic or community association located north of Joint Base
- 10 Andrews;
- 11 12) A representative from a civic or community association located south of Joint Base
- 12 Andrews;
- 13 13) A representative from the United States Congress;
- 14 14) A representative from the Maryland State General Assembly; and
- 15 15) Two members of the general public who reside in Prince George’s County.

16 The Chair/Vice Chair shall be appointed by the County Council for a three year term, subject to
17 reappointment to one year terms of service.

18 The term of service for Committee members shall be two years, subject to reappointment to one-
19 year terms of service.

20 BE IT FURTHER RESOLVED that the Prince George’s County Planning Department of
21 The Maryland-National Park and Planning Commission will provide staff assistance to the
22 committee; and

23 BE IT FURTHER RESOLVED that the JLUS Implementation Committee shall provide an
24 annual report to the Prince George’s County Council of the committee’s activities and
25 accomplishments.
