A RESOLUTION concerning

Task Force for Governmental Operations and Efficiency

For the purpose of establishing a Task Force for Governmental Operations and Efficiency to identify opportunities for the consolidation of services provided by the Board of Education and the government of Prince George's County.

WHEREAS, the citizens of Prince George's County have expressed a desire to increase both per pupil spending and money in the classroom; and

WHEREAS, the County is in the midst of a severe fiscal crisis with very limited resources in order to make the government operate more efficiently; and

WHEREAS, County agencies have reduced or eliminated services and programs and deferred capital improvements needed for an expanding population base; and

WHEREAS, there is a need to provide for the examination of the operations of the Board of Education operating within the County to identify those areas where efficiency and savings can be achieved by consolidation of overlapping or similar functions or responsibilities.

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that a Governmental Operations Efficiency Task Force is hereby created to examine and identify opportunities for consolidation of services provided the Board of Education operating within Prince George's County.

BE IT FURTHER RESOLVED that the Governmental Operations and Efficiency Task Force shall be comprised of twenty-one members, who shall be appointed in the following manner:

- (1) One member shall be appointed by the Chairman of the Prince George's County Senate Delegation;
- (2) One member shall be appointed by the Chairman of the Prince George's County House of Delegates Delegation;
- (3) One member shall be appointed by the County Council and serve as Chairman of the Task Force;
- (4) One member shall be appointed by the County Executive;
- (5) One member shall be appointed by the State of Maryland Board of Education;
- (6) One member shall be appointed by the Prince George's County Board of Education;
- (7) One member shall be appointed by the Prince George's County Educators Association;
- (8) One member shall be appointed from the Parent Teacher Association (PTA) or Parent Teacher Student Association (PTSA) by each Council Member;
- (9) One member shall be appointed by the Association of Supervisory and Administrative School Personnel;
- (10) One member shall be appointed by the Association of Classified Employees (ACE) or School Employees Local 400;
- (11) One member shall be appointed by the Prince George's County Chamber of Commerce; and
- (12) One member shall be appointed by the Prince George's Association of Realtors; and
- (13) One member shall be the Superintendent of Prince George's County Schools or his designee;

BE IT FURTHER RESOLVED that the Council shall appoint appropriate staff to assist and advise the Governmental Operations and Efficiency Task force in its efforts as necessary.

BE IT FURTHER RESOLVED that the Governmental Operations and Efficiency Task Force shall present its findings and recommendations to the County Council within 90-180 calendar days from the date of its appointment.
