## PUBLIC SAFETY & FISCAL MANAGEMENT COMMITTEE REPORT: Date: 7/2/03

Committee Vote: Favorable, 4-0, (In favor: Councilmembers Exum, Bland, Hendershot and Peters.)

This bill will authorize the County to issue and sell an amount not to exceed \$102,484,000 in General Obligation Bonds which includes the \$45,788,000 for the Board of Education projects. All the County projects have previously received borrowing authority through prior legislation that was ratified at referendum.

The projects to be financed are listed in Attachment 1 of the legislation in the Capital Improvement Program of the County for FY2004 through 2009.

The fiscal impact on the County will be negative to the extent of the debt service obligation incurred by the County when the bonds are sold.
