First Reading of Bills (Presentation)

<u>CB-27-2006 – AN ACT CONCERNING HOUSING CODE</u> for the purpose of amending the Housing Code to add safety and security requirements for owners of multifamily rental facilities; to provide time periods for administration, implementation and compliance; to add administrative requirements and procedures for licensing owners of multifamily rental facilities; to require safety and security requirements for the issuance and renewal of multifamily rental facility licenses; and generally relating to multifamily rental facility licenses. - <u>PRESENTED</u>

Council Bill 27 was presented by the Chairman at the request of the County Executive and referred to the Committee of the Whole.

<u>CB-28-2006 – AN ORDINANCE CONCERNING SAFETY AND SECURITY PLANS</u> for the purpose of amending the Zoning Ordinance to require a Safety and Security Plan for the approval of Detailed Site Plans and Specific Design Plans. - <u>PRESENTED</u>

Council Bill 28 was presented by the Chairman at the request of the County Executive and referred to the Committee of the Whole.

<u>CB-29-2006 – AN ACT CONCERNING BUILDING CODE</u> for the purpose of amending the Building Code to add requirements for permitting the use and occupancy of multifamily dwelling units. - <u>PRESENTED</u>

Council Bill 29 was presented by the Chairman at the request of the County Executive and referred to the Committee of the Whole.

<u>CB-30-2006 – AN ACT CONCERNING SAFETY AND SECURITY PLANS</u> for the purpose of authorizing the Police Department to review and approve Safety and Security Plans submitted in conjunction with applications for building permits and multifamily rental facility licenses for owners of multifamily rental facilities of ten (10) or more units. - <u>PRESENTED</u>

Council Bill 30 was presented by the Chairman at the request of the County Executive and referred to the Committee of the Whole.

<u>CB-31-2006 – AN ORDINANCE CONCERNING USE AND OCCUPANCY PERMITS</u> for the purpose of authorizing all immediate reasonable and necessary action to cease and desist the operation of any activity requiring a use and occupancy permit when a use and occupancy permit has not been issued; authorizing all immediate reasonable and necessary action to cease and desist the operation of any activity requiring a use and occupancy permit when a use and occupancy

permit has been issued and is not in compliance with the provisions of the Zoning Ordinance; authorizing all immediate reasonable and necessary action to cease and desist the operation of any activity requiring a use and occupancy permit when the activity is found to present an imminent danger and threat to the health, safety, and welfare of the public by not doing so, that there are no other mitigating circumstances to be taken to resolve the imminent danger and threat to the health, safety, and welfare of the public, and that there are no other reasonable means of preventing further danger and threat to the health, safety, and welfare of the public resulting from the continuation of the activity; authorizing all immediate reasonable and necessary action to cease and desist the operation of any activity requiring a temporary use and occupancy permit when a temporary use and occupancy permit has not been issued; authorizing all immediate reasonable and necessary action to cease and desist the operation of any activity requiring a temporary use and occupancy permit when a temporary use and occupancy permit has been issued and is not in compliance with the provisions of the Zoning Ordinance; authorizing all immediate reasonable and necessary action to cease and desist the operation of any activity requiring a temporary use and occupancy permit when the activity is found to present an imminent danger and threat to the health, safety, and welfare of the public by not doing so, that there are no other mitigating circumstances to be taken to resolve the imminent danger and threat to the health, safety, and welfare of the public, and that there are no other reasonable means of preventing further danger and threat to the health, safety, and welfare of the public resulting from the continuation of the activity; authorizing all immediate reasonable and necessary action to implement this Act for the health, safety and welfare of the public; providing for the designation of certain public officials to enforce this Act; providing for enforcement procedures to implement this Act; providing for establishing policies, rules, and procedures to implement this Act; providing for a hearing before the Zoning Hearing Examiner from a violation of this Act; providing for an appeal from the decision of the Zoning Hearing Examiner to the Circuit Court of Maryland; providing for the computation of time pursuant to this Act; and generally relating to use and occupancy permits.
