1. <u>CB-107-2012</u> (Franklin, Harrison) - An Ordinance concerning repeal of Chapter 10, 2007 Laws of Prince George's County, Maryland, for the purpose of repealing the enactment of Chapter 10, 2007 Laws of Prince George's County, Maryland.

Favorable 3-0 (In favor: Council Members Franklin, Patterson and Harrison)

2. <u>CR-81-2012</u> (Franklin, Harrison) - A Resolution concerning repeal of Chapter 10, 2007 Laws of Prince George's County, Maryland for the purpose of repealing the enactment of Chapter 10, 2007 Laws of Prince George's County, Maryland.

Discussion held in conjunction with CB-107-2012. CR-81-2012 was adopted on October 16, 2012. No committee action required.

**3.** <u>CB-104-2012</u> (Franklin) - A Subdivision Bill for the purpose of incorporating Section 9-206 of the Environment Article of the Annotated Code of Maryland and making changes to the subdivision regulations.

Favorable with recommended amendments 3-1 (In favor: Council Members Franklin, Patterson and Harrison. Opposed: Council Member Olson)

**4.** <u>CR-83-2012</u> (Planning Board) - A Resolution concerning the Implementation in Prince George's County of Senate Bill 236, Sustainable Growth and Agricultural Preservation Act of 2012 for the purpose of adopting the Prince George's County Sustainable Growth Act Tier Map.

Favorable with recommended amendments 5-0 (In favor: Council Members Franklin, Patterson, Harrison, Olson and Toles.)

**5.** <u>CB-99-2012</u> (Patterson) - An Ordinance amending the regulations for certain food or beverage stores in the C-M Zone.

**6.** <u>CB-105-2012</u> (Franklin) - An Ordinance allowing eleemosynary or philanthropic institutions in the R-80 Zone under certain circumstances.

Favorable 4-0 (In favor: Council Members Franklin, Patterson, Olson and Toles.)

**7.** <u>CB-106-2012</u> (Patterson) - An Ordinance amending certain provisions for check cashing businesses.

Favorable 4-0-1 (In favor: Council Members Franklin, Patterson, Harrison and Toles. Abstain: Council Member Olson)

**8.** <u>CB-110-2012</u> (Turner) - An Ordinance permitting reducing/exercise salons or health clubs in the M-A-C Zone.
