Staff oriented the Committee on the supporting resolutions and recommended amendment. Attachment A-2, page 4 was amended to reflect the correct targeted area of District 9 as it pertains to the Economic Development & Training Institute and is reflected in Draft 2 of CR-11-2012.

This resolution amends the Prince Georges County FY 2004, FY 2006, FY 2007, FY 2008, FY 2009, FY 2010, FY 2011 and the FY 2012 Annual Action Plans – to reprogram, restructure and approve funding for Community Development Block Grant (CDBG) and the Emergency Shelter / Emergency Solutions Grants (ESG) activities and to

The Committee reviewed the reprogramming of these funds. Staff oriented the Committee on the comment period and the corresponding supporting resolutions. DHCD Director Eric Brown, Deputy Director Estella Alexander, Assistant Director Renee Ensor-Pope and CPD Administrator Shirley Grant provided comments and answered questions by the members of the Committee regarding the reprogramming process, the new ESG allocations and funding recommendations contained in CR-11-2012.

The Office of Law finds the CR-11-2012 is in proper legislative form and see no legal impediments to its adoption.

The Office of Audits & Investigations found that enactment of CR-11-2012 will not have a negative or adverse fiscal impact on the County since it deals with federal funds.

CR-11-2012 was held in Committee to address questions raised by the Committee members.

#### **BACKGROUND INFORMATION/FISCAL IMPACT:**

This Resolution will amend the FY 2004, FY 2006, FY 2007, FY 2008, FY 2009, FY 2010, FY 2011, and FY 2012 Housing and Community Development Annual Action Plans to restructure, reprogram, and add new CDBG and ESG projects and to include new narrative requirements that apply to the Annual Action Plan and future submissions for receiving ESG funds. This Resolution requires a minimum of one public hearing under the "County Citizen Participation Plan FY: 2011-2015," because it changes the use of CDBG funds from one activity to another and approves funding for new activities.
