#### TRANSPORTATION, HOUSING AND ENVIRONMENT COMMITTEE

Committee Vote, Favorable, 4-0 (In favor: Council Members Harrington, Bland, Dernoga, and Exum)

Staff provided a summary of the resolutions and referral comments that were received. CR-43-2006 establishes an agricultural district for approximately 109 acres. The property is located on the north side of Horsehead Road in the Baden/Brandywine area. Currently, six districts have been established in Prince George's County. The District Manager of Soil Conservation explained the process for filing a petition for an agricultural district and the procedure for selling development rights to the state. Funding for the program comes from the agricultural transfer tax and from the state's share of open space funds. If Prince George's County does not use its agricultural transfer tax within three years for agricultural preservation, the earliest of the three years money will be sent back to the state for use by other counties.

A landowner of active agricultural use may file a petition with the county governing body requesting the establishment of an agricultural district composed of the land owned by the petitioners. The petition must be

reviewed by the agricultural preservation advisory board and the county's planning board. The agricultural preservation advisory board determines if the proposed district meets the qualifications established by the Maryland Agricultural Land Preservation Foundation (MALPF) and whether or not the advisory board recommends establishment of the district. The Planning Board determines if the district is compatible with existing and approved county plans and overall county policy, and whether or not the planning and zoning body recommends establishment of the district.

The District Manager further explained the benefits of such a program. If a landowner eventually sells an easement to the state, the landowner is able to receive some of the equity from his land while still retaining full use of the land for agricultural purposes. This also provides an economic means for the landowner to pass the property on to his heirs and ensure that the land remains in agricultural and open space use. The state benefits in that productive agricultural land remains in production and contributes to the economy. The county benefits in that the land remains in open space, preserves sensitive land in forests and wetlands and is compatible with its efforts in land use planning initiatives such as Commission 2000 and the rural tier.

After approval of the agricultural preservation advisory board and the Planning Board, the Council will hold a public hearing on the petition. The MALPF needs to be in receipt of the petition and accompanying documents by June 21, 2006. Therefore, the public hearing has been scheduled on Tuesday, June 20, 2006.

The MALPF program is a valuable tool to save certain properties in the county. The problem is that the program eligibility is strict and many of our farms are not eligible. The county needs to come up with it's own program tailored to fit our type of farms. A Council Member requested information on particulars of the different programs; the pros and cons of each.

The Office of Law finds CR-43-2006 to be in proper legislative form. The Office of Audits and Investigations determined that enactment of CR-43-2006 will not have an adverse fiscal impact on the county.

# **BACKGROUND INFORMATION/FISCAL IMPACT:**

Subtitle 5 of Title 2 (Agriculture) of the Annotated Code of Maryland provides for the establishment of the Maryland Agricultural Land Preservation Foundation and a procedure for the formation of agricultural districts. This program allows one or more landowners to voluntarily form an agricultural district to encourage the preservation of land. If adopted, this resolution provides the County governing body approval of the petition for the district.
