RESOLUTION

1 A RESOLUTION concerning

2 Maryland-National Capital Park and Planning Commission

3 Capital Budget for Fiscal Year 1997-1998 and

4 Capital Improvement Program for Fiscal Years 1998-2003

5 For the purpose of amending the Prince George's County portion of the Maryland-National
 6 Capital Park and Planning Commission Capital Budget for Fiscal Year 1998 and the Fiscal Years
 7 1998-2003 Capital Improvement Program to adjust appropriation authority for the Park-Schools
 8 Reserve Funds.

9 WHEREAS, Article 28, Section 2-118, of the Annotated Code of Maryland provides for the
 10 amendment of the Capital Budget of the Maryland-National Capital Park and Planning
 11 Commission (the "Commission") by the County Governing Body on its own initiative or at
 12 the request of the Commission after receipt of recommendations from the County Executive and
 13 after public hearing upon reasonable notice to the public; and

14 WHEREAS, the Commission has requested an amendment to the Prince George's County
 15 portion of the Commission's Capital Budget for Fiscal Year 1998, as adopted by CB-53-1997
 16 and the Fiscal Years 1998-2003 Capital Improvement Program, as adopted by CB-54-1997, to
 17 adjust funding authority for the Reserve Fund (Acquisition) Park School (CIP ID #EB000098) in
 18 the amount of \$2,582,000 and the Reserve Fund (Development) Park School (EC000098) in the
 19 amount of \$(582,000); and

20 WHEREAS, the Commission has identified the sources of funding for the amendment as
 21 internal adjustments within Reserve Fund (Acquisition) Park School and the Reserve Fund
 22 (Development) Park School projects; and

1 WHEREAS, the two Reserve Funds -- Acquisition and Development for Park Schools were
2 approved in the Fiscal Year 1998 Capital Budget, as adopted by CB-53-1997 and the Fiscal
3 Years 1998-2003 Capital Improvement Program, as adopted by CB-54-1997; and

4 WHEREAS, funding for these projects was identified as State Aid, M-NCPPC Bonds, and
5 other funds and it has been determined that there is a need to expend Fiscal Year 1998 funds for
6 the acquisition of property for the Park School project; and

7 WHEREAS, the County Executive has recommended to the County Council such
8 amendment; and

9 WHEREAS, the County Council has conducted a public hearing on the proposed
10 amendment having given reasonable notice thereof.

11 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
12 County, Maryland, that the Fiscal Year 1998 Maryland-National Capital Park and Planning
13 Commission Capital Budget and Fiscal Years 1998-2003 Capital Improvement Program is
14 revised to adjust the Reserve Fund (Development) Park School and the Reserve Fund
15 (Acquisition) Park School projects as shown in Attachment "A" attached hereto and made a part
16 thereof.

17 BE IT FURTHER RESOLVED that Fiscal Year 1998 funds for this project shall be derived
18 from the internal transfer of funds from among the two Park School Reserve Funds as identified
19 in Attachment "A."
