2	September 1, 2016, is conveyed to a nonprofit corporation, any redevelopment of said property	
3	shall, upon discontinuation of the medical facility use, be deemed a public procurement and	
4	conform with the prescriptions set forth in Subtitle 2 and Subtitle 10A of this Code for public	
5	procurements. Any conveyance of title to such property to a nonprofit corporation shall mandate	
6	compliance with this Section or said conveyance shall be deemed null and void, and title to such	
7	property shall revert to Prince George's County.
