His background would aid the board and library's management team in a variety of personnel matters, modernizing the library's staffing model, improving labor relations, and strengthening performance evaluation of the library's management. Mr. Sandoe is both a Certified Compensation and Global Remuneration Professional and possesses a degree from Ball State University.

Ms. Chante R. Sedwick, a resident of Bowie, has a strong background in strategic, data-driven communications and leads a division at a major national non-profit. She has over two decades of non-profit leadership experience and understands the advocacy roles performed by the board and the importance of budgetary planning. 
