### BILL

AN ACT concerning

The FY1997-2002 Capital Improvement Program

For the purpose of transferring appropriations between capital projects, amending the approved capital program of the County with regard to expenditures and financing beyond the budget year, and creating a new capital project.

WHEREAS, the Charter of Prince George's County, Maryland, provides for the adoption of the County budget, including the capital program; and

WHEREAS, the capital program sets forth the plan of proposed capital projects to be undertaken in the ensuing fiscal year and in each of the next five fiscal years, and also the proposed means of financing said projects; and

WHEREAS, pursuant to the provisions of Section 818 of the Charter for Prince George's County, Maryland, the County Council may authorize, by legislative act, upon request of the County Executive, underproduced transfers of appropriations between capital project in the Approved Capital Budget; and

WHEREAS, under the provisions of Section 824 of the Charter for Prince George's County, Maryland, the County Council, may, upon receipt of a recommendation in writing from the County Executive, after public hearing and with the affirmative vote of two-thirds of its members, amend the Capital Budget in accordance with such recommendations, without increasing the total amount of appropriations therefore; and

WHEREAS, the County Executive deems it desirable to provide additional

appropriations in the Capital Budget for the Benjamin Davis Elementary School (AA775023), the Hil-Mar Elementary School (AA775093), the Highland Park Elementary Renovation (AA775013), and the Thorne Drive Elementary School (AA775073); and

WHEREAS, the County <u>Executive</u> recommends the creation of a new capital project, the Perrywood Elementary School (AA775103); and

WHEREAS, the County Executive recommends that appropriations can be transferred from the Contingency Fund, as an excess of appropriations over estimated costs in the budget year exists; and

WHEREAS, the County Executive recommends the amendment of the adopted 1997-2002 Capital Improvement Program with regard to the Benjamin Davis Elementary School, the Hil-Mar Elementary School, the Highland Park Elementary Renovation, and the Thorne Drive Elementary School projects to reflect a change in expenditures beyond the budget year; now, therefore,

SECTION 1. BE IT ENACTED by the County Council of Prince George's County, Maryland, that the Fiscal Year 1997-2002 Approved Capital Budget is hereby amended, to provide that appropriations are transferred as follows:
