ZONING BILL

1 AN ORDINANCE concerning

2 Administration - Pre-Application Neighborhood Meetings - Transparency in Land Use

3 For the purpose of requiring the Planning Department to publish on its website a searchable
4 database of informational notifications of pre-application neighborhood meetings; and ensuring
5 that electronic versions of the informational notifications comply with ADA accessibility
6 guidelines.

14 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
15 Maryland, sitting as the District Council for that part of the Maryland-Washington Regional
16 District in Prince George's County, Maryland, that Section 27-3402 of the Zoning Ordinance of
17 Prince George's County, Maryland, being also Subtitle 27 of the Prince George's County Code,
18 be and the same is hereby repealed and reenacted with the following amendments:

(2) Notification

(A) Informational Mailing

* * * * *

(iii) As to residents, an applicant complies with this Section by providing the Planning Department with an electronic version of the informational mailing, which shall comply with Americans with Disabilities Act (ADA) guidance on web accessibility, [more than thirty (30) days before the Planning Department accepts an application] at least thirty (30) days prior to the date of the pre-application neighborhood meeting. The applicant may also notify any person or entity registered in accordance with Subsection (d)(2)(B) of this Section. The Planning Department shall be responsible for emailing informational mailings to residents on the email registry.

* * * * *

(D) Searchable Database

The Planning Department shall maintain a publicly-accessible database of the pre-application neighborhood meeting notifications, as provided by the applicant in accordance with this Subsection (A) above.

(i) The Planning Department shall publish this searchable database in a clear and conspicuous location on the Department’s website.

(ii) The Planning Department shall post each meeting notification to the database within one week of receipt of the electronic mailing from the applicant; and

(iii) This database must permit users to search meeting notifications by Council District.

SECTION 2. BE IT FURTHER ENACTED that this Ordinance shall take effect one hundred eighty (180) calendar days after its adoption.
