This resolution will authorize and approve the Industrial Development (IDA) of Prince George's County to issue new money bonds and bonds to refund all or a portion of the outstanding Series 1993 Bonds and to achieve debt service savings.

The County desires to provide for the refunding of all or a portion of the outstanding 1993 Bonds and the financing of an expansion of a portion of the County Justice Center. The expansion of the Justice Center will consist of constructing, furnishing and equipping approximately 90,000 square feet

addition to the west end of the existing Marbury Wing. The expansion will be leased by the IDA to the County (to which the County will pay rent on an annual appropriation basis).

The fiscal impact of CR-11-2003 is included in CB-17-2003.
