BACKGROUND INFORMATION/FISCAL IMPACT:

The Redevelopment Authority is proposing a six-year Capital Improvement Program. This Resolution approves the proposed Fiscal Year 2025 Capital Budget in the amount of \$8,204,000 for four projects, as follows:

Cheverly Development - \$2,454,00 Old Fairmont Heights HS Redevelopment - \$5,000,000 Gateway Development Authority - \$500,000 Town of Upper Marlboro - \$250,000

The Redevelopment Authority is required to submit its proposed Operating Budget to the County Council for comments. This resolution states the Council's concurrence on the Authority's proposed FY 2025 Capital Budget of \$8,204,000, and an Operating Budget of approximately \$773,900, as well as the Property Management Services Special Revenue Fund amount of \$567,000.
