The Legislative Officer provided a summary of the bill and referral comments that were received. CB-26-2009 prohibits unlicensed vendors from peddling items relating to an event held at the Professional NFL Stadium. The Office of Audits and Investigations provide some additional information; Redskins Officials also provided some additional information. The sponsor indicated that there are grave safety issues to be considered and offered amendments to the bill as was drafted.

The Office of Law determined that CB-26-2009 was in proper legislative form.

The Office of Audits and Investigation indicated there may be some negative fiscal impact on the County as a result of adopting CB-26-2009.
