He will serve as a sworn member and was appointed in 2021.

Ms. Vanessa E. Surles, a resident of Capitol Heights, brings extensive accounting, finance and human resource management skills gained through the non-profit and private sectors. She has been a Volunteer Firefighter/EMT-B since 1992, responding to medical alerts in the community, performing complete medical and psychological assessments. Vice Chair Surles was appointed in 2021 and will serve as a volunteer member.
